FLOOR CLEANER: Dilute 1 ounce of concentrate per gallon of water in mop bucket or automatic scrubber. Mop or auto scrub floors with cleaning solution. Pick up soil and excess cleaner with clean mop or vacuum suction. Rinse mops frequently and change solution as needed.



BATHROOM/TILE CLEANER: Dilute 4 ounces of concentrate per gallon of water. Apply with spray, mop, sponge, or cloth to surfaces to be cleaned. If necessary, agitate to help remove excessive soils. Wipe dry with clean cloth or rinse with clean water as needed.



GENERAL PURPOSE DEGREASER: Dilute 4 ounces of concentrate per gallon of water. Apply with spray, mop, sponge, or cloth to surfaces to be cleaned. If necessary, agitate to help remove excessive soils. Wipe dry with clean cloth or rinse with clean water as needed.

These directions are flexible rather than specific. In many cases a more dilute solution can be used, while for extreme conditions a less dilute solution may be used.
