## 4. FIRST AID MEASURES

### Description of necessary measures

<b>Inhalation:</b>	Remove from exposure area to fresh air. Treat symptomatically and supportively.
<b>Skin contact:</b>	Rinse affected area with large amounts of water until no evidence of product remains. Get medical attention if irritation persists.
<b>Eye contact:</b>	Rinse eyes with plenty of water until no evidence of product remains. Get medical attention if pain or irritation develops.
<b>Ingestion:</b>	Dilution by rinsing the mouth and giving water or milk to drink is generally recommended. Contact physician or local poison control center.

### Most important symptoms and effects, both acute and delayed

After skin contact: Repeated or prolonged excessive exposure may cause irritation. After inhalation: Inhalation of product mist may cause mucous membrane irritation. After eye contact: Moderate to strong irritation of the eyes (redness, swelling, burning, watering eyes). After ingestion: Ingestion may cause irritation of mouth, throat, digestive tract, diarrhea and vomiting.

### Indication of any immediate medical attention and special treatment needed
