4. FIRST AID MEASURES

Undiluted Product:

Immediate medical attention and special treatment needed Contains fluoride compounds. Ingestion of large amounts may cause fluoride toxicity. If ingested, ammonium bifluoride may disrupt the body's electrolyte balance by binding essential metal ions such as magnesium and calcium (hypocalcemia) which may disrupt normal heart and nervous system functions. Disruptions to the body's potassium balance (hyperkalemia) may also occur. Effects may appear immediately or be delayed as much as 4 hours after exposure. Death usually results from uncontrollable ventricular fibrillation. Intravenous calcium chloride or gluconate may be indicated to prevent hypocalcemia. Consultation with a medical toxicologist is advised.
