SECTION 3: HAZARDS IDENTIFICATION

3.1 EMERGENCY OVERVIEW

4.1 FIRST AID PROCEDURES

SECTION 6: ACCIDENTAL RELEASE MEASURES

Working from around the edges of the spill inward, cover with bentonite, vermiculite, or commercially available inorganic absorbent material. Mix in sufficient absorbent until it appears dry. Collect as much of the spilled material as possible. Clean up residue with water. Place in a closed container approved for transportation by appropriate authorities. 7.1 HANDLING

Keep out of the reach of children. This product is not intended to be used without prior dilution as specified on the product label. Avoid breathing of vapors, mists or spray. Avoid prolonged or repeated skin contact. Avoid eye contact with vapors, mists, or spray. Do not spray near flames or sources of ignition. Keep away from heat, sparks, open flame, pilot lights and other sources of ignition. No smoking while handling this material. Avoid contact with oxidizing agents.

7.2 STORAGE

Keep container in well-ventilated area. Store away from heat. Store out of direct sunlight. Store away from acids. Store away from oxidizing agents.

8.2.1 Eye/Face Protection

If the product is not used with the Twist 'n Fill system or if there is an accidental release, the following eye protection is recommended: Indirect Vented Goggles.

8.2.2 Skin Protection
