Description

3M™ Neutral Cleaner Concentrate is a concentrated product. 3M™ Neutral Cleaner Concentrate 3H and 3M™ Neutral Cleaner Concentrate 3L are diluted and dispensed using the 3M™ Twist 'n Fill™ Cleaning Chemical Management System. 3M™ Neutral Cleaner Concentrate 3P is diluted and dispensed using the 3M™ Portable Dispensing System.

Improper use or dilution may result in a decrease in product performance, and may increase the risk of health effects. Ready-to-use neutral cleaner is designed to clean washable hard surfaces.

- 2-liter bottle
- 6 bottles per case

Each 2-liter bottle yields 207 ready-to-use gallons. (Dilution ratio 1:396.)

General Use Directions

Personal Protective Equipment (PPE)

Recommendation: Refer to MSDS for specific PPE guidance.

Ready-To-Use: Avoid eye contact with vapors, mists, or spray. Wear Safety Glasses with Side Shields when eye contact is possible. Gloves not normally required. If prolonged or repeated skin contact is expected, gloves made from the following material(s) are recommended: Neoprene, Nitrile Rubber.

Dispense 3M™ Neutral Cleaner Concentrate 8 with cold water using the appropriate dispensing system into a buddy jug, 3M™ Easy Scrub Express System bottles, mop bucket or directly into an auto scrubber.

1. Sweep or dust mop floors.
2. Properly position caution signs for wet floor conditions.

3. Mop floor or scrub using an auto scrubber or floor machine with a 3M™ Red Buffer Pad 5100.
4. Pick up soiled solution with a wet vacuum or tightly wrung mop.
5. No rinsing required.
6. Allow floor to dry. Note: Floors may be slippery when wet.
7. Burnish or spray-buff immediately after cleaning (optional).

Waste Disposal Method: Incinerate in an industrial or commercial facility in the presence of a combustible material. As a disposal alternative, dispose of waste product in a facility permitted to accept chemical waste. Rinse empty container with water and recycle.
