NO RINSE STRIPPER

PRODUCT DESCRIPTION:

ONCE OVER™ quickly penetrates through floor finish buildup and suspends the stripped finish for rinse free removal. Safe on most resilient and non-resilient floors that include mineral surfaces, terrazzo, concrete, vinyl, vinyl composition, asphalt, rubber, terrazzo, brick and quarry tile. Do not use on linoleum or tile that are in poor condition.

FEATURES:

No Rinse-No Machine:

Leaves no harsh alkaline residue that blocks the adhesion of the sealer or finish. Agitating the solution with a mop brings up the finish.

Efficient Finish Removal:

Quickly penetrates the finish and brings the finish into solution.

Non-ammoniated:

No ammonia odor. Reduces complaints while stripping the floor.

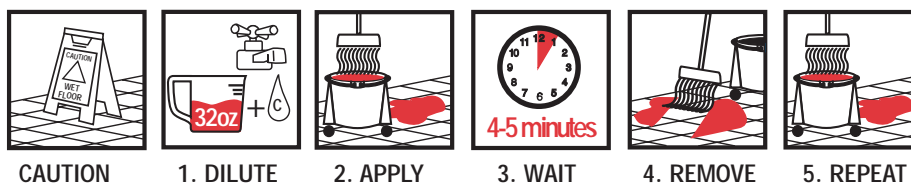

DIRECTIONS

USE INFORMATION:

Before stripping always dust mop the floor and remove gum, labels and other attached soil deposits with a long handled scraper or putty knife.

FLOOR STRIPPING



FLOOR STRIPPING

- DILUTE** at 32 ounces per gallon (1:4 ratio) of cool water. For heavy buildup, dilute 128 ounces per gallon (1:1 ratio) of cool water.
- APPLY** the diluted solution of **Once Over™** onto the floor with a mop.
- WAIT:** Let stand for 4-5 minutes, then agitate with the same mop.
For best results use a rotary machine and black pad. Do not let solution dry.
- REMOVE** the solution from the floor using a mop or wet dry vacuum.
For best results rinse the floor with clean water and a clean mop.
- REPEAT** steps two to four if any finish remains on floor.

SPECIAL PRECAUTIONS: Not for use on linoleum, tile in poor condition, wood or painted surfaces or for daily maintenance of resilient tile floors. Before use on asphalt tile or rubber, test a small hidden area for any color change.

FIRST AID:

If in eyes or on skin, immediately flush with plenty of water for at least 15 minutes while removing contaminated clothing and shoes. Get medical attention. **If inhaled,** remove to fresh air. HANDLING AND STORAGE:

SUGGESTED STORAGE TEMPERATURE: Store inside at 40-90°F. **SPECIAL HANDLING AND STORAGE:** Handle in accordance with good industrial hygiene and safety practices. These practices include avoiding unnecessary exposure and removal of material from eyes, skin and clothing. Store in a cool, dry, ventilated area. **Protect from freezing.** Thoroughly rinse empty containers. **KEEP OUT OF REACH OF CHILDREN.**

PERSONAL PROTECTION:

Respiratory Protection: Not needed under normal conditions.

Ventilation: Use with adequate ventilation.

Eye Protection: Safety goggles w/face shield required.

Protective Gloves: Safety gloves required.

Other Protective Clothing or Equipment: Wear clothing as necessary to prevent skin contact.
